Bills and Financial Review:

- A. Discussion and Approval of Bills & Payroll. Kaye presented bills in the amount of \$7,427.34 Motion by Phelps seconded by Bekken to approve paying the bills as presented. Kaye noted the dental benefit checks no longer show the employee names. Kaye asked what the Swoboda invoice was for. Blok verified the bill was for the group photo session.
