As you may be aware, Fire Chief Greg Janik and Deputy Chief Chris Mantels are teaching Fire Prevention and Life Safety education at Douglas Elementary School. Fire Prevention is a major part of Saugatuck Township Fire District's Community Risk Reduction Program, and we look forward to continuing fire prevention education with the students.

Our goal for the 2018/19 school year is to ensure every home in the Fire District has working smoke alarms and carbon monoxide alarms. We are partnering with parents, students, and educators, to test the smoke alarms and carbon monoxide alarms in their homes.

In the interest of embracing technology, and utilizing social media platforms, we are pleased to introduce the <u>#SPSPresstoTest</u> challenge. The Press to Test challenge requires students and parents to video themselves together, pressing the button on their smoke alarms to test them, and then uploading the videos to Facebook, Instagram, or Twitter with the hashtag #SPSPresstoTest. There will be an Ice Cream social reward upon successful completion of the program at DES.

Sadly, as of December 2018, there have been 125 fatalities in residential structure fires in Michigan. The Fire District and Saugatuck Public Schools are committed to reducing the possibility of injury or death by providing a more focused approach with Community Risk Reduction. Our goal is to ensure our community members and children are provided a reasonable level of safety from the hazards of fire and dangerous conditions. An essential component in achieving this goal is to ensure all homes have working life safety devices.

All homes should be equipped with smoke alarms in every bedroom, and on every floor level of the home, as well as carbon monoxide alarms on every level of the home. If your home does not have these life safety devices, please reach out the Fire District as they have alarms to install FREE of charge. 

MICHIGAN FATAL FIRE STATISTICS JANUARY - DECEMBER 2018



Hose – Initial Attack and Water Supply

PRIORITY:

High

QUALITY FACTORS:

District staff are requesting funds to replace the obsolete initial attack and supply hose. NFPA life expectancy of fire hose is 10 years, and the hose slated to be replaced is on average 20 years old.

The purchase will replace failed, non-complaint and obsolete hose. Hose is an essential component to firefighter safety and minimizing property loss. Currently, the District has no spare compliant 1.75" or 2.5" hose. The Mercedes brand hose is designed for aggressive fire attack, extremely kink resistant at low pressures and includes engraved arrows recessed in the couplings. The highly reflective arrows improve life safety for firefighters by directing firefighters to the escape route.

There was an initial purchase of the smaller attack hose in 2014 for \$12,995 that replaced the hose on the initial attack engines. We do not have any compliant spare hose, or hose to replace what is on the apparatus in the event of failure or the hose needing to be cleaned after deployment.

You may note that the capital plan only outlined \$15,000 for this project. Due to increased manufacturing costs since 2014, duplicating the same hose order is now \$20,005.00 instead of \$12,995. We will be funding the difference of \$5,005.00 by postponing other capital projects.

ITEM DESCRIPTION: LED Lighting & Occupancy Sensors

PRIORITY:

High

QUALITY FACTORS:

District staff are requesting funds to replace the T-8 fluorescent fixtures with LED lighting throughout the entirety of the front station, and back maintenance barn. Many of the existing bulbs, and/or ballasts are currently burned out and require replacement.

District staff feel that converting to LED lighting is better for the environment by reducing the disposal impact on our planet and justifies the investment. Converting to LED keeps chemicals associated with fluorescent type fixtures out of landfills. Additional benefits are the savings in labor costs required for regular fluorescent lamp replacement and estimated utility bill savings.

Per the electrician, it is estimated we will save \$600-800 annually on our station electric utility bill by upgrading to LED Fixtures. The proposed LED lighting comes with a 5-year warranty and is estimated to last over 20 years depending on daily usage.

We are also proposing to install occupancy sensors in all areas, so lights turn on as you enter a room or area for safety and turn off automatically after there is no longer motion in the area. The occupancy sensors would also turn on the appropriate truck bay lights upon return from emergency responses to allow for safer backing of apparatus into the truck bay.

It is estimated that we may receive rebates from the energy company in the amount of \$1,000.00 for the LED upgrades, and \$400.00 for the occupancy sensors, however these are estimates only and will not be confirmed until after installation is completed.







MV Incidents by Month 2016-2018






2018 by Area










Personnel Response To Incidents 2018

Protected Property Value - 2018




