Section 8.1

PAYMENT IN LIEU OF HEALTH INSURANCE

I. PURPOSE

To establish policies and procedures regarding payment in lieu of coverage under the group medical insurance plan.

II. POLICY

Each full-time employee will be given the option of accepting a payment in lieu of participating in the Saugatuck Township Fire District (District) health insurance plan. Payments will be 30% of the hard cap contribution limits under the Publicly Funded Health Insurance Contribution Act and the employee's eligible status (single/double/family).

In order to obtain this payment, the employee must make his/her election by June of each fiscal year. Should the employee elect to waive his/her insurance and obtain the payment, he/she shall not be eligible to participate in the District's health insurance program for that premium year unless a qualifying event per state law. This payment is not available to District employees who are married to another District employee. Employees electing to opt out of the group medical insurance plan must present proof of insurance. The payment made to eligible employees who elect not to participate in the District's health insurance program will be distributed in equal monthly increments.

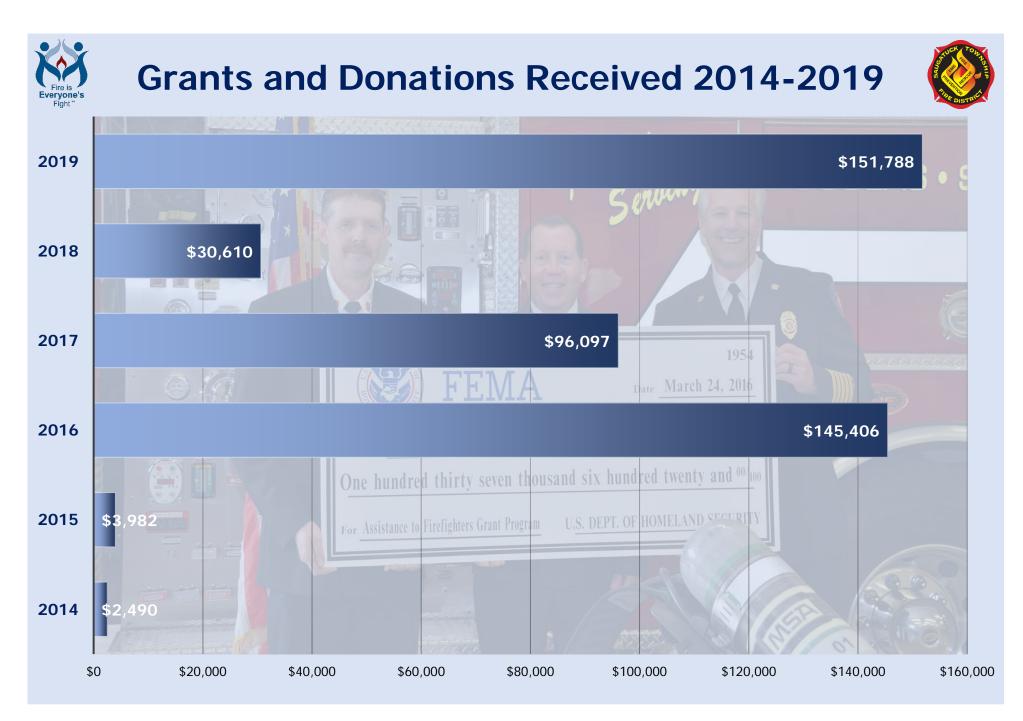

As you likely have noticed, the Fire District is rapidly outgrowing the four walls of the station. The current station, built in 1987, has served the district well for the past 32 years. Continued increase in call volume and responses are requiring us to continue to explore options to better serve the tri-communities.

We wanted you to be the first to know, that we are beginning discussions with the command staff to explore potential options for adding additional sleeping rooms, office space, restrooms, and training areas.

We have no current plan in place but want to begin the discussion with the Township Zoning Administrator to explore what our options might be to work within the required setbacks for our current properties along Blue Star Highway.

Once we have some information from the Township, and some conceptual ideas on paper from the command staff, our desire is to enroll an architect/planner to assist with more formal designs. This will allow us to obtain costs associated for the future project so we can work along-side the Fire Board to continue to plan for the future.

As we obtain additional information, we will continue the discussions with the Fire Board, and eventually our community partners. If you have any questions, please feel free to let us know.

My wife and I are in our 60s and recently bought a new home at the address shown above. We absolutely love our quiet neck of the woods, with the exception of our concern about how emergency vehicles would reach us in the event of a fire or other emergency. In addition to the added delay of traveling south to M89 and then back north a mile to our home, we another concern. Over Labor Day weekend, a tree fell across Lakeshore Drive and vehicles were stopped both north and south bound. While the county worked quickly to remove the tree limb, the road was blocked for at least 10 minutes.

Neighbors mentioned the possibility of a fire lane. I explored the one north of us providing access from the Felker's subdivision to Lakeshore Drive. Is there a possibility of the township creating something similar for the folks south of the washout? I appreciate how much concern there has been about the bike path on Blue Star and it seems this very real risk would also be at the top of the township's list.

My wife and I would feel so much better about the home we just bought with an eye toward retirement, if we felt that our safety was not jeopardized by undue delay in reaching us.
