Fire Administrative Board:

At the last Fire Board meeting held on April 20, 2020, the Board directed me to investigate Hazard Pay for emergency first responders/essential workers. I reached out to several trusted sources for guidance.

First, I contacted Chief David Glotzbach, President of the Michigan Association of Fire Chiefs (MAFC). Chief Glotzbach and I work closely together on numerous fire service issues and he knows the pulse of the fire service and is in continuous contact with our legislative representatives in Lansing.

Basically, the MAFC Executive Board elected to not engage with other State Organization in requesting Hazard Pay from our state legislators & Governor at this current time. There are various points to consider for and against. I have included a few comments below.

- Our job is hazardous, and it is difficult to increase pay rates when engaged in interior firefighting, responding to roadway incidents, Haz Mat, Active Shooter, the list goes on, however, where does it stop
- It is anticipated this COVID-19 event will result in decreased revenues in immediate future years and any additional local funds may well be needed to sustain future budgets
- There is much talk at the Federal Level to provide some form of "Hazard" Pay for all frontline workers in the HEROE's Legislation and other Bills at the Federal Level; providing Hazard Pay at the local level could complicate any potential funding for "Hazard" Pay from the Federal Level and any local funding approved prior to Federal Authorization may not qualify for reimbursement from Federal Funds

 Local officials may be better off to pressure the Governor to find funding that can be passed on to local municipalities to provide equality in this "Hazard" Pay topic to all local emergency responders

I also reach out to Chief Ron Wise, South Haven Area Emergency Services. Chief Wise responded that "they are taking a wait and see approach to see what the Federal Government is going to do". Chief Wise included two links on articles related to Senator Peters idea of Hazard Pay for essential workers. Please see the links below.

The Fire Board may want to consider passing a resolution recognizing the issue and working with State and Federal government to insure "hazard" pay is provided to their personnel, and at the end of the year if nothing transpired from the State and Federal government local consideration/funding would occur.

At the last Fire Board meeting held on April 20, 2020, the Board directed me to ask the Fire District attorney, Jeff Slugget, Bloom & Sluggett, PC, if he felt there is a conflict if represents the Fire Board of Appeals. I reached out to Jeff and I have included his email response below for your review.

I do not believe there is a legal conflict as the BOA is not separate from the STFD. Thus, in the same way, when I represent a community that has a zoning ordinance and someone appeals a decision of the zoning administrator to the zoning board of appeals (ZBA), I can still lawfully represent the community as the ZBA is part of the community. I represent the community and not each and various bodies making up the community. Same, here. I do not represent you (the person who made the decision), I represent the STFD which directs me via the Board.

Having said this, I have absolutely no problem (and I mean this sincerely) with the STFD using other counsel in matters before the BOA either in this case or any time in the future. Critical that Board be comfortable with any of its agents.










Saugatuck Twp. Fire District – ISO PPC Maps – Revised 5/13/2020 - #2102-CM


Original 1980s Lakeshore Drive Washout

Approximate area of Township exceeding 5 road miles from a responding fire station.




