ITEM DESCRIPTION:

Truck #2171 - 2008 Ford F150 - Truck Replacement

PRIORITY:

High

QUALITY FACTORS:

Replacing truck rather than repairing bad engine and transmission. Sell existing as is.

Purchase 2016 Ram 2500 SLT 4x4 Crew Cab ¾ Ton Truck with 6'4" Bed. Install custom aluminum utility body from Arista truck systems. Truck and body to be painted flame red. Included in estimate is necessary wiring, lighting, chargers, and accessories.

We chose the Ram model over the Ford as it comes prepped with necessary console for siren & light controls and reduces the amount of fabrication and labor involved in readying the truck for service.

As part of the Capital Replacement plan, small vehicles are on a 7-year replacement schedule. The goal is the new custom utility body would serve a 2nd duty cycle in 7 years, and be placed on a new cab and chassis at that time. Cost of utility box for 7-year period would be approximately \$7,400.

The 7-year Capital Replacement Plan for smaller vehicles is a general guideline. Trucks will be assessed and replaced on an as needed basis with regards to budget restrictions.
